I/we, the undersigned, hereby authorize the bank to deduct monthly donations from my/our account in favour of 'Christ to the rural world' (CRW), in accordance with the terms and conditions outlined below.

I/we acknowledge that CRW shall not be held liable for any claims, losses, or liabilities arising from incorrect bank details or errors in my/our instructions, including but not limited to failed or erroneous deductions due to insufficient funds or inaccurate information provided.

I/we understand that these transactions will be processed electronically via the GHIPSS automated clearing house (ach) platform and agree to abide by its governing rules.

TERMS AND CONDITIONS

I, PARTNER, (herein referred to as the customer), hereby instruct and authorize CHRIST TO THE RURAL WORLD – the Beneficiary:

1. To issue and deliver a payment instruction or a series of payment instructions to my bank for the purposes of collecting the payment that I am obliged to CHRIST TO THE RURAL WORLD in terms of the Agreement that I have concluded with CHRIST TO THE RURAL WORLD, from my bank account, the details of which are set out above in this authorization and correspond to the banking details above.
2. To issue and deliver payment instructions to my bank in addition to the number of payments as stipulated above in respect of amount that may be in arrears, under the Agreement including but not limited to any arrears interest, penalty costs and charges, that may be accrued as a result of me not having made regular or punctual payment of my obligation as contained in the Agreement concluded with CHRIST TO THE RURAL WORLD: by issuing a new instructions.
3. I understand that in terms of the Agreement that I have entered into with CHRIST TO THE RURAL WORLD, I am obliged to make payments on the instalment due date and CHRIST TO THE RURAL WORLD has the right to collect the payments on the instalment due date but as an indulgence in my favour.
4. CHRIST TO THE RURAL WORLD will endeavor to deliver the payment instruction or each payment instruction in a series of payment instructions to my bank on the day on which my salary is paid into my bank account, provided that such date be a date on or after the instalment due date and that I will ensure that sufficient funds are available in my Bank account at the time.
5. The payment instructions(s) I have authorized to be issued will be processed by using ACH direct debit order provided by my bank, now or in the future. I understand that the details of each deduction will be printed on my bank statement or on any accompanying voucher provided by my bank.
6. CHRIST TO THE RURAL WORLD and my bank will treat the payment instruction(s) issued by CHRIST TO THE RURAL WORLD, as if I had issued the instruction(s) to my bank myself:
 - I will pay any bank charges levied by my bank relating to these deductions;
 - I may cancel this authority by giving CHRIST TO THE RURAL WORLD thirty (30) days' notice, in writing, sent by prepaid registered post to CHRIST TO THE RURAL WORLD.
 - By cancelling this authority, such cancellation will not cancel the Agreement and I will remain responsible for ensuring that the instalment is paid to CHRIST TO THE RURAL WORLD on each instalment becoming due and payable, as per this authority;
7. I shall not be entitled to any refund of amounts, which CHRIST TO THE RURAL WORLD has deducted in terms of this Authority that was still in force and an outstanding balance owed by me to CHRIST TO THE RURAL WORLD still existed; Should I still have an outstanding balance owed by me to CHRIST TO THE RURAL WORLD, by the stipulated end date, the direct debit order shall stay in force until the balance is cleared.
8. I will be responsible for ensuring that the account nominated above does not become inaccessible for any reason and undertake to immediately notify CHRIST TO THE RURAL WORLD in the event of my salary not being paid into my bank account, as set out in this authority.
9. I indemnify my bank and hold it harmless against all costs, charges, expenses, losses and damages, which I may suffer as a result of my banking act in accordance with this authority. I further indemnify my bank against any claim by a third party arising from the performance or non-performance, as the case may be, in terms of this authority.
10. CHRIST TO THE RURAL WORLD has agreed to give an advanced notice of the amount at least 10 days before the date of first debit through the customer's e-mail address or an SMS.
11. If an error is made by any of the parties involved, you are guaranteed a full and immediate refund to your own bank account by the originator of the error.
